#### Important dates (revised)

Due to bureaucratic delays and the intervening holiday period, the Organizing Committee has decided to revise the important dates - as they are stated in the 1st Announcement - as follows:

- Submission of participation application by February 10, 2024 (instead of January 20, 2024). The date is indicative and aims to facilitate the organization of the Conference.
- Submission of abstracts by March 15, 2024 (instead of February 29, 2024). Guidelines for writing the abstracts are provided in the next paragraph.
- Approval of abstracts by April 10, 2024 (instead of March 30, 2024).
- Submission of full text and final abstract by June 30 (instead of June 20, 2024).
- Final approval of articles by July 30 (instead of July 20, 2024)

**INSTRUCTIONS FOR WRITING ABSTRACTS**

Given that the abstracts will be submitted for approval by the Scientific Committee of the Conference, authors are kindly requested to use the attached template for formatting the abstract.

- The title of the paper should be written in uppercase letters, bold font, centered alignment and Arial 14 pt fonts.
- Immediately following the title, the names of the authors should be presented (Arial 11 pt fonts). In the case of multiple authors, on the right side of each name, a number in exponent form should be indicated, corresponding to the author's affiliation and organization. The name of the presenting author should be underlined.
- Keywords follow (mention 3 to 5), using Arial 11pt fonts.
- Authors are requested to indicate the thematic section they believe their work falls under.
- The abstract text can be in Greek or English and should not exceed 350 words (excluding keywords, title, names, and affiliations), using Arial 11 pt fonts.
- The text should not include tables, charts, or images.
- The Scientific Committee reserves the right to suggest possible modifications, additions, or clarifications and may choose not to accept the abstract.
- The final categorization into thematic sections is determined by the Scientific Committee, which will evaluate the abstracts.
- Authors will be notified of the acceptance or rejection of their abstracts, as well as any comments from the Scientific Committee, via email by April 10, 2024. Detailed instructions for the preparation of the final text will follow.
